### **CALL TO ORDER**

# OTIS ELEVATOR DISCUSSION

Crawford Ward stated that some of the front railings on some units need to be painted and Michael Shumrak will schedule for this repair work.

Crawford stated that the pool lights have not been coming all since the last power failure. Michael will schedule this.

Crawford stated that there has been an issue with an owner's dog (listen), Josh Martin, attorney, recommended an upgrade to the Association's rules/regs to address this issue. The Board discussed how to handle this since it is not an Association issue but decided to have the attorney draft some language to address this with the owner.
